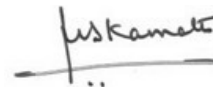

CGSI continues to play an important role in **public policy and regulatory consultations**. We have maintained regular engagement with bodies such as:

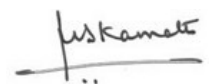
- **Insurance Regulatory and Development Authority (IRDAI)**

Minutes of the 58th ANNUAL GENERAL MEETING of Consumer Guidance Society of India (CGSI), held on 12 September 2025 at Late Sripad Dattatraya Tendulkar Mangal Karyalay, Chatrapati Shivaji Maharaj Marg, Mahim, Mumbai 400 016.

The meeting began at the scheduled time, 5.00 PM. Dr. M. S. Kamath, Hon. General Secretary, invited the office bearers on the dais. The office bearers were welcomed with flower bouquets. Dr. M. S. Kamath thereafter invited CGSI Chairman, Dr. Dixit, to give his welcome address to the gathering.

Welcome Address by Consumer Guidance Society of India, Chairman Dr. Sitaram Dixit

Dr. Dixit welcomed all the participants to the third General body meeting for the current year, the previous two general body meetings being for amending the constitution and to update it in consonance with the changing times and changing concepts in the world of consumerism. Dr. Dixit regretted that during this year the Maharashtra State discontinued the Consumer Helpline that CGSI had been operating for about 12 years. This was as per the Government of India decision to centralize all such services through a single national portal based in New Delhi.

Dr. Sitaram Dixit informed that CGSI's core activities in carrying out consumer education sessions, redress individual consumer complaints, and handling consumer grievances effectively continued as in previous years, and would now continue with additional focus without the responsibility of running the Govt helplines. Dr. Dixit congratulated and welcomed all members, to the first Annual General Body Meeting held under the amended CGSI constitution and requested the President to take charge of the proceedings.

Address by CGSI President Shri. Sunil Karve

The President, Shri Sunil Karve, welcomed all participants to the AGM. He congratulated the CGSI Constitutional Amendment Committee for effectively revising the constitution and getting it approved. He also appreciated all the voluntary work being carried out by CGSI members. The President thereafter asked the Hon. Secretary to start the AGM proceedings.

Confirmation of the minutes of 57th AGM held on Friday, 20 September 2024, Special General Body Meeting held on Friday, 6 June 2025 and Extra Special General Body Meeting held on Friday, 25 July 2025

The minutes of the 57th Annual General Meeting, Special General Body Meeting and Extra Special General Body Meeting had been circulated well in advance to all members. As there were no queries or comments, Dr. Kamath requested the house to take the minutes of all the three meetings as read and confirmed.

Presentation of Annual Report for FY 2024-25:

The Hon. Secretary, Dr. Kamath, informed members that post publication of the Annual report, CGSI received a favorable order from the Mumbai High court against Vodafone in the matter of providing details of incoming calls to consumers. Vodafone's contention was that since it does not charge for incoming calls, it is not bound to provide these details. The court held the argument untenable and ordered the company to provide details of incoming calls. The Hon. Secretary commended the 4-year long efforts and persistence of Shri. Rajeev Singhal and Shri. Rajesh Kothari for getting the favorable decision.

The Hon. Secretary also thanked Shri Chetan Prabhu for his voluntary donation of Rs. 2,000.00 to CGSI.

The Annual Report for 2024-25 had also been circulated well in advance and Dr. Kamath requested the house to adopt the same.

Presentation of Accounts for 2024-25:

While presenting the accounts, the Hon. Treasurer, Shri. Nandakumar Menon stated that the surplus for FY2024-25 was much less than the previous year on account of investment of Rupees Eighty-five Lakhs.

Shri. Menon, also said that the queries on accounts received from Shri Satra regarding increase in travel expenses and outstanding Income Tax refund had been answered to the member's satisfaction. The Hon. Treasurer informed the meeting that the outstanding refund of Income Tax is expected shortly. The audited financial for FY 2024-25 then approved.
